  - 2. The Department of Pediatrics, KJSMC runs the MD (Pediatrics) course of MUHS since 2003.
  - 3. MD (Pediatrics) student guided by Dr. Varsha Phadke stood 2<sup>nd</sup> in the merit Certificate Winner list of MUHS (Convocation 2021).
  - 4. Dr. Varsha Phadke and Dr. Priyashree Mukherjee have successfully completed the Basic Research Methodology course in 2012 and 2021 respectively.
  - 5. Dr. Varsha Phadke is GSMC FAIMER Fellow (2008) and faculty.

- 6. Research projects of MD students, MBBS students, Intern, Medical Education research projects and Interdisciplinary collaborative research projects are being routinely carried out in the department.
